- **Cancellations** made more than fourteen (14) days prior to the event do not receive the deposit back unless the cancellation occurs more than thirty (30) days prior to the event date, in which case the deposit may be refunded at the Club's discretion
- **Gratuity:** A 20% gratuity will be added to the final bill for the Garden Room hosts
